SECURING FEE:

During the year before a new pupil is due to take up a guaranteed placement, a **non-refundable, non-deductible entrance fee of R25,143,00** will be required.

PLEASE NOTE:

Monthly invoices / statements will be emailed to you by the 22nd of every month. For monthly payments, account to be settled by the 26th of every month commencing on 26th December 2024 and ending on 26th November 2025.

Tuition fees and all other imposts in terms of this agreement are payable annually in advance. Interest is added to late payments. The rate of interest is the maximum rate of interest for incidental credit as set out in the National Credit Act 2005. Proof of direct deposits must be submitted to the school. Outstanding accounts of older than 30 (thirty) days may be submitted to credit bureau for potential blacklisting and any resultant costs will be added to the outstanding account for payment.
