For security purposes, cash is not accepted on the school premises. Tuition fees and all other imposts in terms of this agreement are payable annually in advance. Interest is added to late payments. The rate of interest is the maximum rate of interest for incidental credit as set out in the National Credit Act 2005. Proof of direct deposits must be submitted to the school. Outstanding accounts of older than 30 (thirty) days may be submitted to credit bureau for potential blacklisting and any resultant costs will be added to the outstanding account for payment. No exception to the payment options will be permitted. The onus is on the parent/s/guardian/s to ensure payments are made timeously. **NB: A full term's written notice (or fees in lieu of) is required should your child be leaving the school.**
